2. **Permitted uses of Application:** As End User you agree to use the Application only as provided, and Content only as an integral component of the Application. You agree that You are only permitted to use the Application for educational purposes and shall not use the Application for research or commercial purpose, unless You obtain written consent from the University, otm@illinois.edu.
